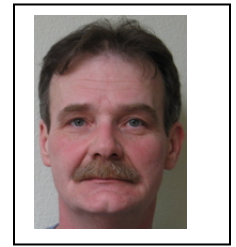

The Douglas County Sheriff's Office is releasing the following information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision in State v. Ward, which authorizes law enforcement agencies to inform the public of a sex offenders release when; in the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the sheriff's office in the county of their residence. Further, their previous criminal history places them in a classification level which reflects their potential to re-offend. The sex offender has served the sentence imposed on him/her by the courts, and has registered with the Douglas County Sheriff's office. **He/she is not wanted by law enforcement at this time.** This notification is not intended to increase fear; rather, it is our belief that an informed public is a safer public. The Douglas County Sheriff's Office has no authority to direct where a sex offender may live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he/she chooses.

**CURRENT OFFENSE:** Mr. Barnes most recent conviction was for Malicious Mischief in the 2<sup>nd</sup> Degree and Assault in the 4<sup>th</sup> Degree D.V. Mr. Barnes has sex convictions for Rape in the 3<sup>rd</sup> Degree, Assault with Sexual Motivation, and Residential Burglary with Sexual Motivation.

**RELEASE CONDITIONS:** Mr. Barnes is not under the supervision of the Department of Corrections for his sex offense convictions.

**RISK LEVEL JUSTIFICATION:** Mr. Barnes scores within the Level 3 Classification using the Washington State Sex Offender Risk Level Assessment Instrument.

**SOURCES OF INFORMATION:** NCIC III, Police Reports, Pre-Sentence Investigation Reports.
