The Douglas County Sheriff's Office is releasing the following information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision in State v. Ward, which authorizes law enforcement agencies to inform the public of a sex offenders release when; in the discretion of the agency, the release of information will enhance the public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the sheriff's office in the county of their residence. Further, their previous criminal history places them in a classification level which reflects their potential to re-offend. The sex offender has served the sentence imposed on him/her by the courts, and has advised the Douglas County Sheriff's Office that he/she will be living at the location above. **He/she is not wanted by law enforcement at this time.** This notification is not intended to increase fear; rather, it is our belief that an informed public is a safer public. The Douglas County Sheriff's Office has no authority to direct where a sex offender may or may not live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he/she chooses.

CURRENT OFFENSE: Mr. LaGrange was convicted of 2nd Degree Child Molestation in 1999. Mr. LaGrange offended against a 13 year old female who lived in his home. Mr. LaGrange has previously been convicted of Child Molestation in the First Degree, for offending against a 7 year old female.

RELEASE CONDITIONS: None

RISK LEVEL JUSTIFICATION: Mr. LaGrange scored within the Level 3 rating criteria established by the Department of Corrections.

SOURCES OF INFORMATION: NCIC III, Judgement and Sentence, Pre-Sentence Investigation report, End of treatment summary report, Polygraph examination reports.
