The Douglas County Sheriff's Office is releasing the following information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision in State v. Ward, which authorizes law enforcement agencies to inform the public of a sex offenders release when; in the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the sheriff's office in the county of their residence. Further, their previous criminal history places them in a classification level which reflects their potential to re-offend. The sex offender has served the sentence imposed on him/her by the courts, and has registered with the Douglas County Sheriff's office. **He/she is not wanted by law enforcement at this time.** This notification is not intended to increase fear; rather, it is our belief that an informed public is a safer public. The Douglas County Sheriff's Office has no authority to direct where a sex offender may live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he/she chooses.

**CURRENT OFFENSE:** In 2002 Mr. Lowman was convicted of Cummunication with a Minor for Immoral Purposes in Snohomish County. The victim in this offense was a 15 year old girl who was not related to Mr. Lowman.

**RELEASE CONDITIONS:** None

**RISK LEVEL JUSTIFICATION:**Mr. Lowman has been arrested three times for sex offenses. At least two of those arrests resulted in convictions. Mr. Lowman scores within the Level 3 Offender range using the Department of Corrections Risk Level Assessment instrument.
