SCARS/MARKS/TATTOOS:

The Douglas County Sheriff's Office is releasing the following information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision in State v. Ward, which authorizes law enforcement agencies to inform the public of a sex offenders release when; in the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the sheriff's office in the county of their residence. Further, their previous criminal history places them in a classification level which reflects their potential to re-offend. The sex offender has served the sentence imposed on him/her by the courts, and has registered with the Douglas County Sheriff's office. **He/she is not wanted by law enforcement at this time.** This notification is not intended to increase fear; rather, it is our belief that an informed public is a safer public. The Douglas County Sheriff's Office has no authority to direct where a sex offender may live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he/she chooses.

CURRENT OFFENSE: 03/23/2006 four counts of Possession of Depictions of a Minor Engaged in Sexually Explicit Conduct. 01/22/1996 Child Molestation in the First Degree.

RELEASE CONDITIONS: No contact with minors, No internet, No email, No pornography, No frequenting places where minors are likely to congregate.

RISK LEVEL JUSTIFICATION: In addition to his convictions, Mr. Horsfall has many additional self disclosed victims. Mr. Horsfall was rated as a Level 3 Offender by the Department of Corrections and scores within the Level 3 guidelines using the Washington State Sex Offender Risk Level Assessment Instrument.

SOURCES OF INFORMATION: NCIC, JIS, DOC, Grant County Sheriff's Office, Treatment Provider reports, and polygraph reports.
