Introduction

This Voter Challenge Summary and accompanying Due Diligence materials are presented alongside the sworn Voter Challenge Form Affidavit and with reference to RCW 29A.08.810(1)(c)(ii)(A) – (E).

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/ mailing letters and querying online databases as required) and via others (e.g., tracking letters handled by USPS, contacting county staff regarding property ownership, obtaining canvasser/occupant affidavits).

This Challenge is not based upon unsupported allegations or allegations of anonymous third parties.

It is noted hearsay evidence is admissible in support of this Challenge. (Ref. RCW34.05).

Having exercised due diligence to personally verify the evidence presented on information and belief, following is the factual basis for the Challenge:

Background

Registrant GABRIELLE ELAINE MOSER, YOB 1987, (the “REGISTRANT”) is registered with a residence address of 117 Ponderosa Rd., East Wenatchee WA 98802. There is a separate mailing address on file for the REGISTRANT in the Voter Registration Database (“VRDB”) of 1266 N Seven Golds Ave., Eagle ID 83616.

The REGISTRANT appears to be registered to vote in Idaho and recently voted on 5 November 2024 in Idaho. The REGISTRANT has no voting record in Washington state.

Letter

On 15 September 2025, I mailed a letter via USPS Certified Mail to the registered address on file in the VRDB, notifying the REGISTRANT that the residence address listed in the VRDB is incorrect. The letter encouraged the REGISTRANT to cancel their registration and included an official Washington State form. A copy of the letter was mailed to the separate mailing address.

Data Searches

Data obtained from this source on 12 September 2025 shows a Gabrielle Moser with an age consistent with the birthyear listed in the VRDB at the address of 1266 N Seven Golds Ave., Eagle ID. There is no working landline phone number in Washington state. There is an alias (a.k.a.) of Gabrielle Elaine Moser Neira listed.

Data obtained from this source on 12 September 2025 shows a Gabrielle Moser with an age consistent with the birthyear listed in the VRDB at the address of 1266 N Seven Golds Ave., Eagle ID. There is no working landline phone number in Washington state. Jair Neira is listed as a possible relative.

A 12 September 2025 search returned Jair Neira as the name of the “primary” owner of the address comprising the mailing address listed for the REGISTRANT in the VRDB. It is notable the REGISTRANT is registered in Idaho with “Neira” as a further surname.

As of 1 August 2025, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Gabrielle Elaine Moser with a birthyear of 1987 with a residence address of 117 Ponderosa Rd., East Wenatchee WA with no voting history.

The VoteRef website, containing the voter registration databases of at least 30 states, shows Gabrielle Elaine Moser Neira, with an age consistent with the REGISTRANT’s age in the VRDB, registered to vote in Idaho on 5 November 2024 and voted in the 5 November 2024 general election in Idaho.
