## LAWRENCE TRAPP – WA12960316: Voter Challenge Summary

### Introduction

This Voter Challenge Summary and accompanying Due Diligence materials are presented alongside the sworn Voter Challenge Form Affidavit and with reference to RCW 29A.08.810(1)(c)(ii)(A) – (E).

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/mailling letters and querying online databases as required) and via others (e.g., tracking letters handled by USPS, contacting county staff regarding property ownership, obtaining canvasser/occupant affidavits).

This Challenge is not based upon unsupported allegations or allegations of anonymous third parties.

It is noted hearsay evidence is admissible in support of this Challenge. (Ref. RCW34.05).

### Background

Registrant LAWRENCE TRAPP, YOB 1978, (the “REGISTRANT”) is registered with a residence address of 11 Old Ferry Rd., Orondo WA 98843. There is a separate mailing address on file for the REGISTRANT in the Voter Registration Database (“VRDB”) of 153 High Leaf Dr., Raeford NC 28376.

The REGISTRANT appears to now be more recently registered to vote (and is voting as recently as 5 November 2024) in North Carolina at the separate mailing address listed in the VRDB. There is also evidence the REGISTRANT owns the property comprising the separate mailing address in the VRDB, indicating this is his actual domicile and permanent residence.

### History

The Washington Voter Research Project has developed research and data raising a query the REGISTRANT may hold UOCAVA status on the Washington state VRDB. Regardless, further to Washington state’s residency requirements, registering to vote more recently in another state extinguishes voting residency in Washington state. <https://www.sos.wa.gov/elections/voters/voter-eligibility-resources/residency-requirements>

### Letter

On 15 September 2025, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the REGISTRANT that the residence address listed in the VRDB is incorrect. The letter encouraged the REGISTRANT to cancel their registration and included an official Washington State form. A copy of the letter was mailed to the separate mailing address.

There is no landline phone number in Washington state with an area code associated with Eastern Washington state.

The VoteRef website, containing the voter registration databases of at least 30 states, shows Lawrence Richard Trapp, with an age consistent with the REGISTRANT's age in the VRDB, registered to vote in North Carolina on 27 August 2024 at the separate mailing address listed in the VRDB and voted in the 5 November 2024 general election in North Carolina.


## **Conclusion**

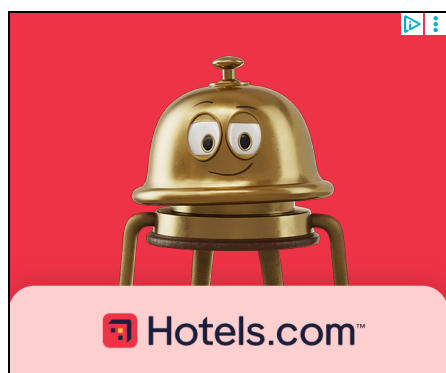

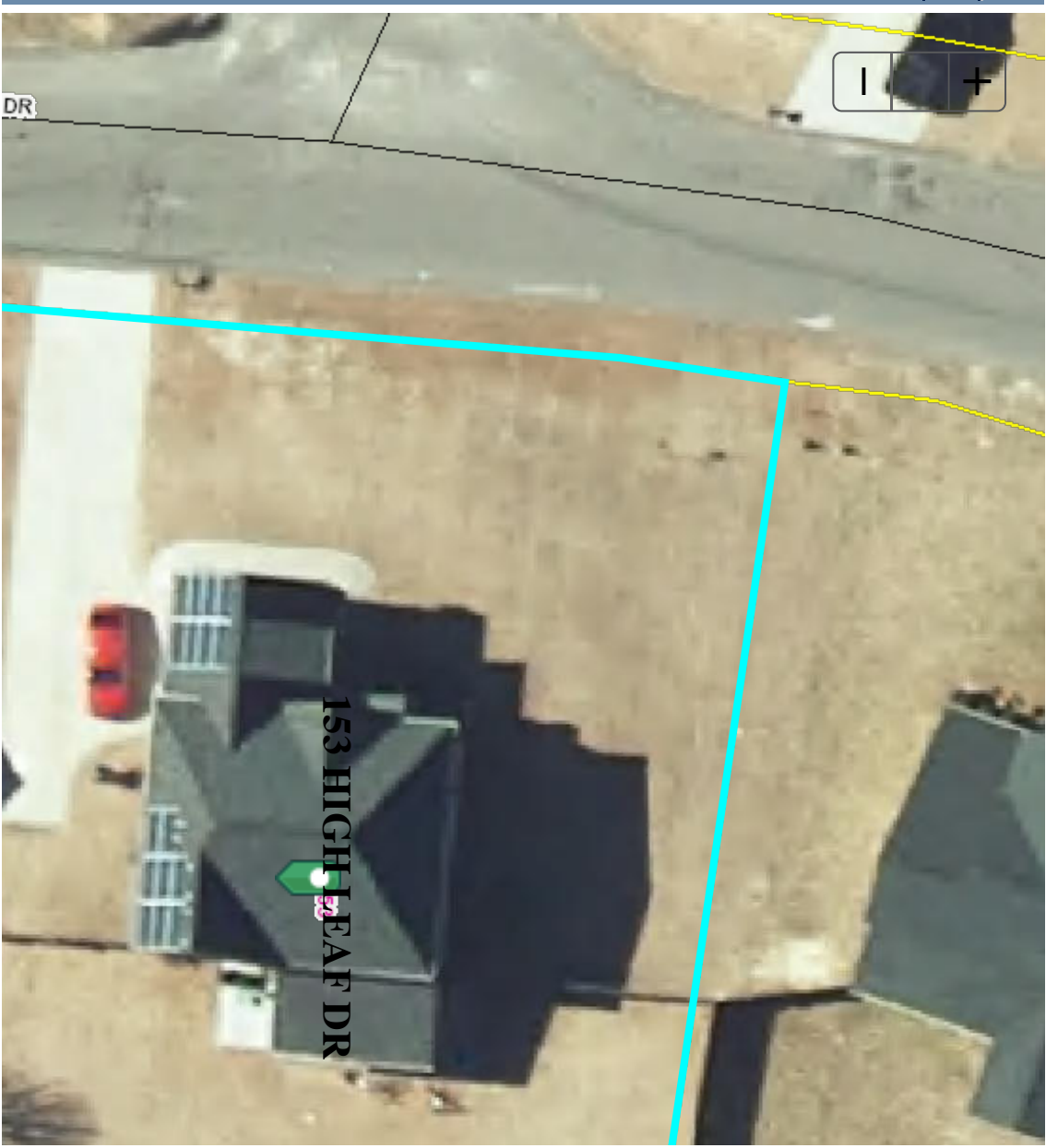
