

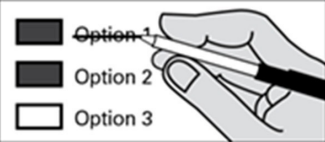
How to vote

Douglas County Port District

Proposition No. 1

CONCERNS THE PORTS OF CHELAN AND DOUGLAS COUNTIES UNIFYING TAX LEVY RATES ACROSS DISTRICTS.

This proposition, as enacted by Resolutions 2023-1 and 2023-2, would unify the tax levy rate encompassing both districts collected in 2024 and in subsequent, consecutive years. The Port of Chelan County levy rate for 2023 is 0.175 cents/\$1,000 of assessed value. The Port of Douglas County levy rate for 2023 is 0.137 cents/\$1,000 of assessed value. Using 2023 levy rates, a unified tax levy would be approximately 0.164 cents/\$1,000 of assessed value for both districts. Should this proposition be:

Okanogan and Douglas Counties (Three Rivers Hospital) Bonds For New Hospital

The Commission of Public Hospital District No. 1, Okanogan and Douglas Counties, Washington, adopted Resolution No. 2023-03 concerning a proposition for the construction of a new hospital and related health care facilities. If approved, this proposition would authorize the District to construct, equip and furnish a new hospital and carry out other capital improvements deemed necessary or advisable by the Commission; issue no more than \$72,000,000 of general obligation bonds maturing within 30 years; and levy annual excess property taxes to repay the bonds, all as provided in Resolution No. 2023-03. Special Election Hospital District One Year Excess Levy
